**Information on how to enter and prizes form part of these Terms and Conditions.  
By participating, you agree to be bound by and comply with these Terms and Conditions.**

### **1. Promoter and Competition Partner**

### **2. Competition Period**

The competition commences at 10.00AM AEST on Tuesday 5 August 2025 and ends at 11.59PM AEST on Monday 1 September 2025 ("Competition Period"). Entries received outside this period will not be accepted.

### **3. Eligibility**

The competition entry is open to residents of New South Wales, South Australia, Queensland, Western Australia, Australian Capital Territory, Tasmania and Victoria aged 18 years or older. It excludes employees of the Promoter or its holding or subsidiary company, Stellantis Australia and Reflections Holidays and their immediate families, anyone connected professionally with the prize draw, or any person where entering this competition breaches any law or regulation of the jurisdiction in which they are resident.

In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. Only one entry per person will be available (**Eligible Entrant**).

#### 4. How to Enter

## **8. Prize Redemption and Conditions**

8.1 The **Jeep Avenger Summit loan** is subject to Jeep's standard loan agreement, including insurance and maintenance requirements. Conditions include:

- a) The Vehicle prize will be dropped off and picked up by the winner from Jeep Tweed Heads, 17/123 Minjungbal Dr, Tweed Heads South NSW 2486, Australia, or Jeep Gold Coast, 65 High St, Southport QLD 4215, Australia. This will be coordinated with the winner by Stellantis Australia. The Promoter's decision is final.
- b) It is a condition of accepting the Prize that the Prize Winner may be required to sign a legal release or any other documentation, including a vehicle loan form, in a form determined by the Promoter in its absolute discretion.
- c) In the event that the Vehicle is involved in an accident or damaged in anyway, the Prize Winner must comply with any other conditions specified by the Promoter, and an Accident/Damage Report in the form required by

the Promoter must be completed and forwarded to the Promoter's from which the Vehicle was collected from within 24 hours of the damage occurring. Repairs to the Vehicle are not to be undertaken without the written consent of the Promoter or its appointed assessor, and the cost of any excess will be sole responsibility of the Prize Winner.

- d) The driver of the car must have a current Australian State or Territory licence (which is not under suspension or cancellation) as at the date on which the Prize Winner is to drive the vehicle. The Prize Winner is to return the Vehicle to the Promoter immediately upon completion of the Prize and if the Prize Winner fails to do this, the Promoter is irrevocably authorised to enter any premises in which they believe the Vehicle to be situated and take possession of and remove the Vehicle.
